## FEE DESCRIPTIONS

Registration and Building Usage Fees are **NONREFUNDABLE** and are due at the time of registration. Registration fees are used to cover administrative costs, supplies, etc. Building usage fees are used to help offset the heating and air conditioning, wear and tear, and maintenance costs of the Cornerstone facility. These may be combined and should be made payable to HCA.

Supervisor Checks: HCA cannot function without our supervisors! They help set up, break down, and clean. Most importantly, they are responsible for making sure the students are always supervised and don't leave with anyone not authorized to pick them up. They are also responsible for managing any emergencies. Your checks are the only way they are compensated for their effort and commitment. Please remember to keep the *date and payee blank* for your supervisor check.

All tuition and fees are to be paid at the time of registration. Your child is not registered until full payment is made and all documents are returned. HCA instructors have committed to teach your children during the school year and as a result, instructor's checks are **NONREFUNDABLE** for any reason after July 31, 2025. Supervisor checks are non-refundable after July 31, 2025.
